Payment Options

- Pay in full - \$200 for the 1st class / \$180 each additional class (additional class options applies to both siblings and multiple classes, discount only available with this option)
- Installment payments - 3 payments of \$75 each - Due January 15th, February 16th, and March 15th

It is important that payments are made on time to ensure that all costumes can be ordered and received on time. If payment is late, students will not be allowed to participate in class until full payment is received. All costumes will be donated back to Academie Da Vinci for use in future productions. RULE AND POLICIES of ADV Dance Club 2015-2016

- 1) I understand that all Dance Club information will be sent via email. It is my responsibility to make sure I read all information. I will keep you updated on any changes in my email address.
- 2) I understand that class placement is determined by the instructor, and I am willing to support the decisions and selection of class placement.
- 3) I explicitly give my consent to the instructor to gently lay their hands on the student for purposes of dance instruction.
- 4) I understand that if I have a question or concern regarding the policies or decisions made by the Dance Club Director, I will request a personal appointment with the appropriate party. I understand that negative comments, concerns, or complaints should be addressed with the Dance Club director and not on social media.
- 5) As a parent, I understand that a positive attitude and continued support is necessary in order for my child to continue the privilege of participating in the dance club program. I also understand that if I, or my child, choose to have a negative attitude or cause volatile scenes in any way, my child will be asked to leave Dance Club and there will be no refunds, credits or transfers of funds paid.
- 6) Dance Club follows Pinellas County School closure schedule including Pro Ed Days and will be closed during all major holidays.
- 7) I understand that there will be no adjustments or credits for missed classes.
- 8) Minimum Class Size: I understand the minimum class size is 5 students. Fewer students may result in a schedule change.
- 9) Payment: All payments must be received by the date of specified payment agreement - in full by your child's start date or installments as specified on the registration form.
- 10) Withdrawal from dance club can happen at the parent or teacher's discretion. At no point does withdrawing constitute a refund.
- 11) I understand that there will be a \$30.00 charge applied to account for returned checks. I understand that if my amount due is not paid on time, my child will not be allowed to participate in dance club.
- 12) I give permission for my child to be photographed and videotaped during productions, performances, rehearsals and for Dance Club promotional purposes.
- 13) I understand that all costumes will be donated to Academie Da Vinci and must be returned within one week of the final Dance Club performance of the semester.
- 14) I have read and understand the above rules and policies and I understand that Dance Club reserves the right to refuse services to any person who does not support the policies and decisions set forth.
